**Awards:** Awards to top 10 in each division.

Age Divisions: Youth, Junior Olympic athletes, are ages 18 and under in two-year divisions determined by calendar year of birth. Open athletes

are ages 19-39 and Masters are ages 40-44, 45-49, etc.; divisions are determined by age on date of meet.

**Proof of Age:**Junior Olympic athletes must upload proof of age documentation to their USATF membership profiles. Allow five business days

for USATF National Office to process birth date verification.

Teams: Team competition contested in all divisions. AGAIN THIS YEAR: 15-16, 17-18 boys and girls can combine run as a

separate boy or girls team to qualify to go to nationals. (ie. you can run as a 15-18 HS team to qualify for nationals.) Teams MUST be registered with Wisconsin USATF prior to competition. For further information on team registration contact:
